



## President's Message

Another eventful and successful year for the Chester Historical Society concluded on May 31, 2018. Finishing its 48th year, the organization eagerly opens the 2018 museum season and is forming plans for its 50th anniversary in April 2020.

Our excitement this past year, however, was tempered by the March passing of our founding president and longtime cheerleader, Barbara Delaney. Along with a few other enthusiastic Chester residents, Barbara and husband Edmund (pictured) were at the forefront when the Chester Historical Society rapidly ascended from concept to reality. The launch occurred in less than two months as more than 100 founding members attended the Society's first meeting on April 24, 1970. Barbara Delaney served as the organization's president for its initial six years.

Barbara's spirit and influence were ever present. Perhaps her most visible legacies are two historical Chester buildings. One of the Society's first projects was restoration of the Old Town Hall, which was re-opened as the Meetinghouse on Memorial Day 1973. As the Society neared its 30th anniversary, Barbara was once more in the front row, encouraging the purchase of the 1860 Griswold Mill building that became the Society's first home. In June 2010, Barbara and Bob Blair, a fellow Society founder, opened the doors when Chester Museum at The Mill welcomed visitors for the first time.

Barbara often used the phrase "Onward and Upward" at the close of meetings or events, words that have become an inspiration for us to research and then identify imaginative opportunities to share Chester's rich history with others. We are so driven...Onward and Upward. Thank you, Barbara!

## Programs and Exhibits

There have been several noteworthy programs and events this past year. Our participation in the Chester Fair, where we highlighted several recent acquisitions to our collection, as well as promoting future events and programs, attracted 620 visitors. In September we promoted and participated in what has now become an annual event—The Old-Time Baseball Game. Although Chester did not prevail on the field this time, the event was very successful, attended by more than 275 tri-town fans.

During the winter months CHS held two very successful lectures and book signings, the first by Nate Jacobson, *The Waterhouse Grist Mill Saga*, on Nov. 12. Max Miller discussed his book, *Along the Valley Line*, on Jan. 21. Each attracted a crowd of more than eighty people who were intensely interested in the presentations.

Several programs were done for students of the Chester Elementary School. The Exhibits Co-chairs, Jackie Stack and Nancy Watkins made great presentations last June and even on Halloween this past October. Second graders will be coming to the museum later this month.

More than 950 people visited our museum this past year, enjoying the freshening of the *Streams of Change* upstairs exhibit and praising the Chester-oriented postcard exhibit in our seasonal exhibit area downstairs.

Along with the postcards were exhibits of Three Chester Notables—noted illustrator and artist, Hugh Spencer; The Leatherman, featuring a full-sized sculpture of him by our own Weymouth Eustis; and a stunning presentation of the life and career of noted Civil Rights lawyer and activist, Constance Baker Motley, presented in the main by Marta Daniels.

This year's seasonal exhibit, *Two Streams & Many Industries*, opened on June 1 to wide acclaim. As with past exhibits, the committee co-chairs are indebted to our curator, Diane Lindsay, for providing the vast majority of artifacts and materials used in the exhibit. The exhibit was also made possible by the research and efforts by Skip Hubbard, Cary Hull, Nate Jacobson and Rob Miceli.

The exhibit focuses on the development of Chester industry along the two branches of the Pattaconk Stream that run through town. It promises to promote and develop the history of the town and attract more townspeople to our museum.

## History Preservation

The History Preservation Committee is responsible for the Society's collections, for accessioning new items, as well as cataloging and preserving the collection.

We accepted many donations this year, most notably a box of Silliman ledgers, journals and time books from the Berkshire Historical Society in Pittsfield, MA.

Pat Kosky, Ruth Thayer, Janice Benda and I continued to work most Tuesday afternoons and Friday mornings in the Meeting House Archive Room. We thank Ruth Thayer for her many years of work and, especially, her organizational skills, as she has retired from active participation in our group.

We work with the Exhibit Committee, researching records, photographs and artifacts in our collection to put on display. We have researched questions from Society members and other people. We have also scanned photographs for our collection, so the originals can be retained by families.

Through the year, the Society has continued to record oral histories from longtime residents for our archives. We hope to incorporate this personalized history into our future exhibits.

In the fall, the Society published Nathan Jacobson's book, *The Waterhouse Grist Mill Saga*, about the Waterhouse brothers whose grist mill on Goose Hill Road was the earliest industry in Chester. The book is another essential element of the Society's history preservation.

# Development/Fundraising

A high priority for the Development Committee this past year was the continued retirement of member interest-bearing notes, totaling \$35,000. The notes replaced a mortgage on the Mill eight years ago and are valued at \$2,500 each.

This winter, the Society received an unrestricted donation of \$10,000 from Richard Spencer, which the Trustees approved to pay off four notes. Two additional notes were retired with success in managing the annual operating budget. Therefore, the debt on the Mill building at the start of FY 2018-19 is \$20,000.

Ongoing maintenance and improvements of the building and grounds at the Mill have required additional financial planning.

Fortunately, this was a good year for the Annual Appeal. The year-end drive reached a new high of more than \$12,300, covering nearly 44% of our initial operating budget.

Our Creative Challenge in April netted \$3950, thanks to the craftsmanship of 30 artists creating "pegs" artworks for our silent auction, and nearly 100 people attending the event at the Meeting House.

With the success of the Annual Appeal and the Creative Challenge, monetary donations and the continued growth of the investment fund, the Society had a balance of \$82,952 at year-end.

Additionally, the Society received from the Community Foundation of Middlesex County a grant for \$2486, which it is sharing with Deep River Historical Society. The two societies are in the two-year-long process of digitizing historical films of the towns to share through programs, classrooms and our museums.

## Finances

Revenues for the annual operations of the Society are generated from three primary sources: membership dues, donations (Annual Appeal, museum visitor box, other) and fundraising events. Principal expenses for general operations include servicing our loan obligation, utilities, insurance and accounting, general maintenance, preservation and cataloging of archives, and exhibits.

Our Annual Appeal response continues to set new highs, this year topping \$12,000 with a 50% participation rate from membership. A one-time unrestricted gift, plus success in our operations, enabled us to retire \$15,000 of notes, reducing the open balance to \$20,000 at fiscal year end.

Following a reprint of the popular *Ferryboat* book, our funds allocated for Society publications remains strong with a balance in excess of \$10,000.

Essex Savings Bank customers voting for the Chester Historical Society as a favorite charity resulted in \$417 for the Society, the 6th consecutive year we have been the society with the most votes. We also received a \$500 corporate grant from Essex Savings Bank to offset the postage of mailing newsletters and annual reports.

## Membership

As of May 2018 the Society has 227 current memberships, a net increase of 15 from the prior year (see back page). We added 19 new memberships to our rolls and processed seven membership upgrades, including five to Life. By level, we currently have 41 Individual memberships, 78 Family, 26 Benefactors and 82 at the Life level.

### Robbie Collomore Music Series

The 44th season of the Robbie Collomore Music Series was both an artistic and financial success. The All in the Fall grouping of concerts again proved to be popular with a record attendance.

The first concert of the season was our annual Barbara and Edmund Delaney Young Artist Concert featuring the Claremont Trio. This concert was a repeat appearance for cellist Julia Bruskin, who performed in 2015 with her husband Aaron Wunch on piano. The second concert was also a repeat appearance for classical guitarist Jason Vieux and bandoneon artist Julien Labro, who previously was the accordion player with the Hot Club of Detroit.

The November concert featured Hartford natives, the Curtis Brothers, with Ray Vega on trumpet. Their Latin Jazz brought down the house. The final concert was Ranky Tanky, American Roots Gospel Singers. Their performance of music from America's southeastern sea islands was a unique musical experience.

The Cornwall Trust has shown steady continued growth and we maintain a somewhat more defensive posture due to unsure economic and political stability worldwide. Because of the increasing complexity in organizing the concert season, the Collomore Committee decided to hire a part-time manager, Ann Drinan.
